After 37 straight Gallup surveys over a 21-year period, most Americans continue to say abortion should be illegal in nearly every circumstance. In Gallup's most recent survey conducted between May 6 and May 10, a combined 55 percent of respondents said abortion should be illegal in all or all but a few cases. A breakdown of the numbers finds 29 percent who agreed abortion should be legal "under any circumstances"; 13 percent who felt it should be legal "under most circumstances"; 36 percent who said it should be "legal only in a few circumstances"; and 19 percent who said it should illegal "in all circumstances." Two percent stated they had no opinion. In a data sheet released with the May survey, Gallup provided results of 37 surveys dating back to September 1994 in which respondents answered the question, "Do you think abortions should be legal under any circumstances, legal only under certain circumstances, or illegal in all circumstances?"
